

Community Funding Program – Safe Communities - Domestic and Family Violence Grant

PENRITH CITY COUNCIL

Overview

The Safe Communities - Domestic and Family Violence Grant funds community organisations and groups to deliver primary prevention initiatives targeting the underlying drivers of domestic and family violence to prevent violence before it happens.

Grant Objectives

The aim of the Safe Communities Grant is to fund primary prevention initiatives that target the underlying drivers of domestic and family violence, through activities that:

- increase community awareness and education about the drivers of domestic and family violence.
- are community-led.
- encourage community organisations and groups to collaborate.
- respond to the needs of community experiencing intersectional inequality.
- build capacity, skills and knowledge of workers and volunteers about primary prevention practices.
- strengthen social networks and knowledge about support services for communities vulnerable to domestic and family violence.

Proposed activities must meet one or more of the objectives. All proposed activities must align with principles of access, inclusion, and equity.

We encourage applications from First Nations groups and organisations, and those that support and celebrate First Nations individuals, communities and culture in Penrith.

Definitions:

Primary Prevention

'Primary prevention' means addressing the drivers of violence against women and children by promoting gender equality, healthy relationships



and the wellbeing of people of all genders (as it pertains to domestic and family violence prevention). The aim of primary prevention is to stop violence before it happens.

Available Funding

The Safe Communities Grant is a pilot program which will run for three years up to June 2027.

The total amount of funding available for the Safe Communities Grant is **\$20,000** per year.

Tier One – Sole Applicant

Applicants may apply for a grant up to a total funding amount of **\$2,500**.

Tier Two – Partnership Application

Additionally, grant applicants who can demonstrate a partnership with another organisation or group may request funding for an additional \$2,500 to a total funding amount of **\$5,000**. This does not include an auspicing arrangement. Partnership must:

- include the applicant and one or more organisations or groups that meet Council's eligibility criteria.
- provide evidence of agreed partnership.
- outline how the partnership will benefit the proposed activity.

Grant Timelines

This grant is open twice per year. For relevant dates and information, please find details on <u>penrith.city/grants</u>.

Successful recipients of this grant are required to:

- conduct their initiative within 12 months of signing funding agreement.
- negotiate with Council and confirm in writing any proposed changes to the scope as outlined in grant application.
- submit a final acquittal report upon completion of the initiative.

Failure to acquit the grant will affect any future funding requests.



Application Requirements

Applications must be completed and lodged (with all relevant information) on or before the closing date advertised.

Applicants are required to demonstrate that they are able to acquire all appropriate insurances, licenses and approvals for their proposed activity. If the application is by an unincorporated organisation, then it should provide evidence of auspice from an incorporated organisation.

Successful applications must be willing to enter into an agreement with Penrith City Council and be solely responsible for the delivery of the initiative and expenditure of funds. Where there is a partnership, one organisation must be solely responsible for the agreement and delivery of the activity and expenditure of funds.

Eligible Applicants

Applicants must:

- provide services or be located in the Penrith LGA and deliver initiatives in the Penrith LGA that benefit Penrith residents.
- be a not-for-profit organisation that is incorporated or have evidence of auspice from an incorporated organisation with an ABN.

Ineligible Applicants

Applicants must not:

- be a school or other government agency. Groups associated with schools, for example Parent & Friend committees are eligible to apply.
- have overdue progress or acquittal reports for previous Penrith City Council grants.
- have outstanding debts with Penrith City Council.
- submit more than two grant applications, per grant per round.



Eligible Activities

- One-off activities e.g. activity that is held once or reoccurs within the defined period of the grant.
- Capacity building activities e.g. workshops and training opportunities for workers, volunteers and community members.
- Primary prevention activities e.g. programs, events, workshops, social awareness campaigns.

Ineligible Activities

Funding cannot be used for:

- reimbursements for activities already undertaken.
- operating costs associated with running an organisation or group e.g. salaries and office or computer equipment.
- initiatives with the sole purpose of fundraising.
- activities that duplicate Council's existing initiatives.
- initiatives previously funded through other Penrith City Council Community Funding Program grants.
- activities that cannot be delivered within 12 months from receipt of funding agreement.

Reporting and Acquittal Requirements

As custodians of public funds, Council needs to know that recipients can manage funds and prioritise financial accountability. As such, all grant recipients are required to report on and acquit their activities as detailed in the funding agreement.

Report templates are available and are required to be submitted through SmartyGrants.

Applicants are required to report on the success of the activity in terms of the agreed outputs and outcomes, and relevant data that has been collected.



Detailed financial reports will also be required and grant recipients will be required to provide documentation and evidence of expenditure.

Assessment Criteria

Grant applications must be submitted on time and meet application and grant eligibility requirements. If eligibility is met, the application will be assessed against the assessment criteria below.

| Capacity | Grant application demonstrates the capacity and experience of the applicant to deliver the proposed initiative. |
| Objectives | Grant application clearly demonstrates how the proposal will support primary prevention initiatives that target the underlying drivers of domestic and family violence to stop violence before it happens. Grant application clearly outlines how the proposal responds to one or more objectives of the Safe Communities Grant. |
| Need | The grant application provides evidence of the need for the initiative and proposed outcomes. |
| Connection | The grant application demonstrates a connection to, and/or benefit for, the local community and how the proposed activity addresses the specific needs of intended participants. |
| Partnerships | Proposals seeking funding above \$2,501 (only). |
| | The proposal provides evidence of partnership and demonstrates the value of partnership. |
